

“BRITEX CHRISTMAS SHOPPING SPREE” PROMOTION

Terms and Conditions

1. Information on how to enter and the prize(s) forms part of the Terms and Conditions. Entry into the competition is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents who are 18 years and over. However, employees and their immediate families of the Promoter and their associated agencies and companies are not eligible to enter.
